If a state qualifier from this district cannot participate or misses the RSVP window, the next available alternate from that same division will be notified directly by us after the RSVP window closes. The OFFICIAL results with scholarship breakdowns for both the 11-under divisions and the 12-up divisions (State Finals) will be available after the completion of the State Finals. All funds raised from this district will be pro-rated directly into each division's scholarship fund.
