Bowlers in the U12, U15 & U20 scratch divisions will qualify from District to State based on a ratio of 1:5 or major fraction thereof, including last place ties per division. All qualifiers are marked in the scratch results and are posted online at **CalUSBC.com**. It will be the bowler's responsibility to check for their name online to see if they qualified. At the State Finals, each division will earn scholarships and one of six berths into the 2015 Junior Gold Championships (CHICAGO, IL) if they have not already previously qualified. The California USBC will also provide each champion with a travel stipend to Chicago valued up to \$400. **State Finalists must REGISTER their squad time online in order to bowl in the State Finals. THE RSVP WINDOW IS MARCH 30 (9AM)–APRIL 5 (7PM).** If a state qualifier from this district cannot participate or misses the RSVP window, the next available alternate from that same division will be notified directly after the RSVP window closes.

The OFFICIAL results with scholarship breakdowns will be available by June 3. All funds raised from this district will be pro-rated directly into each division's scholarship fund.

We also encourage your youth bowlers to visit us at **CalUSBC.com** to receive information on scholarship awards and other tournaments available such as our Youth State Championships held this summer in Dublin/Fremont, Diddy Watts Youth State Singles Challenge (formerly the State Scratch Youth tournament) held in July/August at AMF Visalia Lanes and our Adult Youth Scholarship Doubles event this June held at three different locations in the state. We also offer a \$500 youth scholarship award that can be applied for. You can download all entry forms, scholarship applications and tournament results online.
