Bowlers in the U12, U15 & U20 scratch events will qualify from District to State based on a ratio of 1:5 or major fraction thereof, including last place ties per division. All qualifiers are marked in the scratch results and are posted online at **CalUSBC.com**. It will be the bowler's responsibility to check for their name online to see if they qualified. **State Finalists must REGISTER their squad time online in order to bowl in the State Finals at Classic Bowl, Daly City on May 6-7. THE RSVP WINDOW IS MARCH 30 (9AM)–APRIL 5 (7PM).** At the State Finals, each division will earn scholarships and one of six berths into the Junior Gold Championships to be held in Cleveland, OH if they have not already previously qualified. The California USBC will also provide each division champion with a travel stipend to Indianapolis valued up to \$400. If a state qualifier from this district cannot participate or misses the RSVP window, the next available alternate from the same division will be notified directly after the RSVP window closes.

The OFFICIAL results with scholarship breakdowns will be available by June 7. All funds raised from this district will remain in this district's scholarship fund and will be pro-rated by division. We encourage your youth bowlers to visit us often at **CalUSBC.com** to receive information on scholarship awards and other tournaments available such as our Youth State Championships held this summer in San Rafael (July) and the Diddy Watts Youth State Singles Challenge (formerly the State Scratch Youth tournament) held July 29-30 (local qualifiers) and August 12-13 (McHenry Bowl, Modesto). We also offer a \$2500 Star of Tomorrow Award and a \$1000 youth scholarship award that can be applied for. Please download all entry forms, scholarship applications and tournament results online. Thank you for your support and participation in this year's Pepsi tournament. Your hard work and dedication in helping these youth bowlers participate is very much appreciated. We look forward to seeing you and your bowlers at the Pepsi State Finals!

RSVP Window: MARCH 30 (9am) – APRIL 5 (7pm) • State Finals: MAY 6-7

STATE FINALS QUALIFIERS: State Finalists (U12, U15 & U20 divisions) will qualify (scratch) from District to State based on a ratio of 1:5 or major fraction thereof, including last place ties per division. **IT IS THE STATE FINALIST'S RESPONSIBILITY TO CHECK ONLINE AT CALUSBC.COM BEFORE MARCH 30 TO SEE IF THEY QUALIFIED TO THE STATE FINALS. QUALIFIERS MUST REGISTER THEIR SQUAD TIME ONLINE BEFORE APRIL 5 IN ORDER TO BOWL.** Space is limited and filled on a first come, first serve basis.

FORMAT: \$10 ON-SITE ENTRY FEE. Qualifiers must select one squad, which consists of six (6) games moving pairs after each game. Each division will earn scholarships and one of six berths into the 2017 USBC Junior Gold Championships (CLEVELAND, OH) if they have not already previously qualified. Champions, scholarships and Junior Gold berths will be determined by total scratch pinfall per division. The California USBC will also provide the six division champions a travel stipend to Cleveland valued up to \$400. **CALIFORNIA ALSO OFFERS AN OPTIONAL HANDICAP SCHOLARSHIP DIVISION (100% OF 210) ON-SITE.**

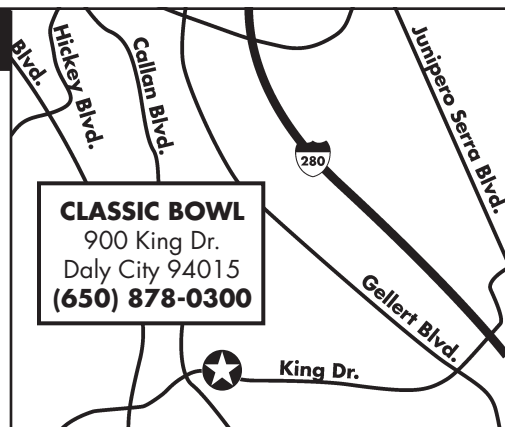
