2017 PEPSI STATE FINALS RSVP & TOURNAMENT INFO

For bowlers that have qualified from the District Finals to the State Finals. Please read the tournament rules carefully.

RSVP Window: MARCH 30 (9am) – APRIL 5 (7pm) • State Finals: MAY 6-7

STATE FINALS QUALIFIERS: State Finalists (U12, U15 & U20 divisions) will qualify (scratch) from District to State based on a ratio of 1:5 or major fraction thereof, including last place ties per division. ***IT IS THE STATE FINALIST'S RESPONSIBILITY TO CHECK ONLINE AT CALUSBC.COM BEFORE MARCH 30 TO SEE IF THEY QUALIFIED TO THE STATE FINALS. QUALIFIERS MUST REGISTER THEIR SQUAD TIME ONLINE BEFORE APRIL 5 IN ORDER TO BOWL.*** Space is limited and filled on a first come, first serve basis.

FORMAT: \$10 ON-SITE ENTRY FEE. Qualifiers must select one squad, which consists of six (6) games moving pairs after each game. Each division will earn scholarships and one of six berths into the 2017 USBC Junior Gold Championships (CLEVELAND, OH) if they have not already previously qualified. Champions, scholarships and Junior Gold berths will be determined by total scratch pinfall per division. The California USBC will also provide the six division champions a travel stipend to Cleveland valued up to \$400. ***CALIFORNIA ALSO OFFERS AN OPTIONAL HANDICAP SCHOLARSHIP DIVISION (100% OF 210) ON-SITE.***

DIRECTIONS: From the north: 101 South to 280 (Daly City). Exit Hickey Blvd. and turn right. Turn left on Gellert Blvd. and Turn right on King Drive. Bowl will be on the right. **From the south:** 101 North to 280 (San Francisco). Exit Westborough/Avalon and continue onto Junipero Serra Blvd. Turn left on King Dr. Bowl will be on the right.

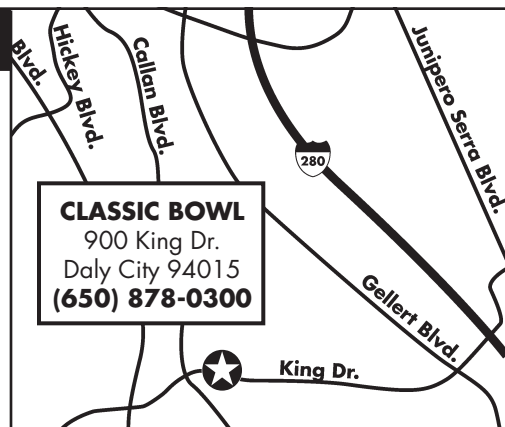

You will be immediately notified ONLY if there is a problem. **MAKE SURE YOUR REGISTRATION WENT THROUGH CORRECTLY – AN AUTOMATED EMAIL WILL BE SENT TO YOU WITH A SUMMARY OF REGISTRATION.** All registrations must be verified – OFFICIAL CONFIRMATIONS will be sent by mail. **BRING YOUR MAILED CONFIRMATION LETTER TO THE STATE FINALS FOR CHECK-IN.** If you do not receive your letter by April 30, contact us immediately. Confirmed finalists will be posted online at CaUSBC.com. Contact your coach for help if you don't know the required information. **E-mail registrations will NOT be accepted.
