Bowlers in the U12, U15 & U20 scratch events will qualify from District to State based on a ratio of 1:5 or major fraction thereof, including last place ties per division. All qualifiers are marked in the scratch results and are posted online at CalUSBC.com. It will be the bowler's responsibility to check for their name online to see if they qualified. State Finalists must REGISTER their squad time online in order to bowl in the State Finals at Winnetka Bowl, Winnetka on May 5-6. THE RSVP WINDOW IS MARCH 30 (9AM)—APRIL 13. At the State Finals, each division will earn scholarships and one of six berths into the Junior Gold Championships to be held in Dallas, TX if they have not already previously qualified. The California USBC will also provide each division champion with a travel stipend to Texas valued up to \$400.

The OFFICIAL results with scholarship breakdowns will be available by June 6. All funds raised from this district will remain in this district's scholarship fund and will be pro-rated by division. We encourage your youth bowlers to visit us often at CalUSBC.com to receive information on scholarship awards and other tournaments available such as our Youth State Championships held this summer in Norwalk (July) and the Diddy Watts Youth State Singles Challenge (formerly the State Scratch Youth tournament) held June 30-July 1 (local qualifiers) and August 11-12 (Rancho Bowl, Santa Maria).
