Bowlers in the U12, U15, U17 & U20 scratch events will qualify from District to State based on a ratio of 1:5 or major fraction thereof, including last place ties per division. All qualifiers are marked in the scratch results and are posted online at **CalUSBC.com**. It will be the bowler's responsibility to check for their name online to see if they qualified. **State Finalists must REGISTER their squad time online in order to bowl in the State Finals at Double Decker Lanes, Rohnert Park on May 4-5. THE RSVP WINDOW IS APRIL 6-14.** At the State Finals, each division will earn scholarships and one of eight berths into the Junior Gold Championships to be held in Detroit, MI if they have not already previously qualified. The California USBC will also provide each division champion with a travel stipend to Detroit valued up to \$400.

The OFFICIAL results with scholarship breakdowns will be available by June 5. All funds raised from this district will remain in this district's scholarship fund and will be pro-rated by division. We encourage your youth bowlers to visit us often at **CalUSBC.com** to receive information on scholarship awards and other tournaments available such as our Youth State Championships held this summer in Oroville (July) and the Diddy Watts Youth State Singles Challenge (formerly the State Scratch Youth tournament) held July 27-28 (local qualifiers) and August 10-11 (McHenry Bowl, Modesto). We also offer a \$2,500 Star of Tomorrow Award and a \$1,000 youth scholarship award that can be applied for. For bowlers that have qualified from the District Finals to the State Finals. Please read the tournament rules carefully.

RSVP Window: APRIL 6-14, 2019 • State Finals: MAY 4-5, 2019

STATE FINALS QUALIFIERS: State Finalists (U12, U15, U17 & U20 divisions) will qualify (scratch) from District to State based on a ratio of **1:5** or major fraction thereof, including last place ties per division. ***IT IS THE STATE FINALIST'S RESPONSIBILITY TO CHECK ONLINE AT CALUSBC.COM TO SEE IF THEY QUALIFIED TO THE STATE FINALS. QUALIFIERS MUST REGISTER THEIR SQUAD TIME ONLINE APRIL 6-14 IN ORDER TO BOWL.*** Space is limited and filled on a first come, first serve basis.

FORMAT: \$10 ON-SITE ENTRY FEE. Qualifiers must select one squad, which consists of six (6) games moving pairs after each game. Each division will earn scholarships and one of six berths into the 2019 USBC Junior Gold Championships (DETROIT, MI) if they have not already previously qualified. Champions, scholarships and Junior Gold berths will be determined by total scratch pinfall per division. The California USBC will provide the eight division champions a travel stipend to Detroit valued up to \$400. ***CALIFORNIA ALSO OFFERS AN OPTIONAL HANDICAP SCHOLARSHIP DIVISION (100% OF 210) ON-SITE.***

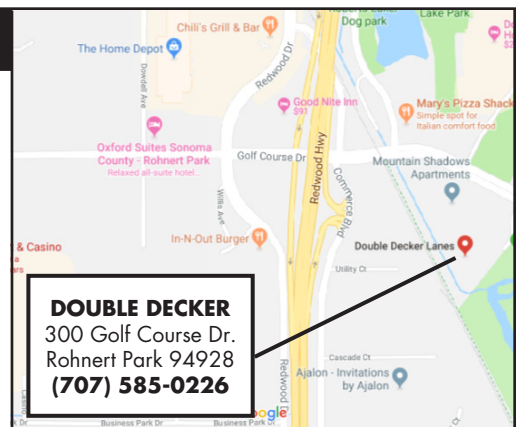
