All qualifiers are marked in the scratch results and are posted online at CalUSBC.com. It will be the bowler's responsibility to check for their name online to see if they qualified. State Finalists must REGISTER their squad time online in order to bowl in the State Finals at Double Decker Lanes, Rohnert Park on May 4-5. THE RSVP WINDOW IS APRIL 6-14. At the State Finals, each division will earn scholarships and one of eight berths into the Junior Gold Championships to be held in Detroit, MI if they have not already previously qualified. The California USBC will also provide each division champion with a travel stipend to Detroit valued up to \$400.

The OFFICIAL results with scholarship breakdowns will be available by June 5. All funds raised from this district will remain in this district's scholarship fund and will be pro-rated by division. We encourage your youth bowlers to visit us often at CalUSBC.com to receive information on scholarship awards and other tournaments available such as our Youth State Championships held this summer in Oroville (July) and the Diddy Watts Youth State Singles Challenge (formerly the State Scratch Youth tournament) held July 27-28 (local qualifiers) and August 10-11 (McHenry Bowl, Modesto). 
