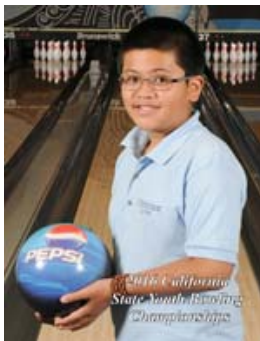

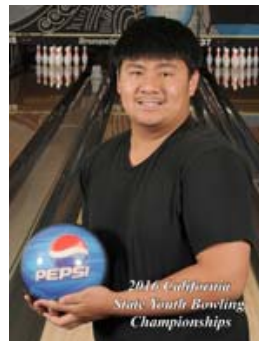

The 2016 California Pepsi Youth Bowling Championships is now completed and six new Champions have emerged. This is a long tournament. It starts with league-level qualifying competition in November and January and then the District Finals are held in March at eight different locations over two different weekends. Based on a ratio of 1:2 from league level to District, a total of 465 bowlers participated in the U8 & U10 Divisions and 1,791 participated in the U12, U15 & U20 Divisions. The first place finishers in the U8 & U10 Divisions at the District Finals earned a FREE entry into the 2016 Youth State Championships to be held this July in Lake Forest. The first place finishers in the U12, U15 & U20 Divisions at the District Finals earned a \$50 scholarship plus a qualifying spot into the Semi-Finals of the Diddy Watts State Singles Challenge to be held at McHenry Bowl in Modesto August 13-14. Bowlers in the U8 & U10 Divisions would survive through two rounds of qualifying and three rounds of qualifying for the U12, U15 & U20 Divisions (all qualifying levels were based on scratch scores). 52 winners in the U8 & U10 Divisions will earn District Scratch Scholarships and \$12,087 will be awarded in District Handicap Scholarships to 239 winners. Every bowler was automatically entered in the District Handicap Division and \$5 from each entry was allocated for these awards.

The State Finals were held at Fountain Bowl on May 7-8. Bowlers in the U12, U15 & U20 divisions qualified to this level based on a ratio of 1:5 from District to State. We had 330 bowlers travel from across the state to attend and bowl in six game blocks. 33 of these bowlers will earn Scratch Scholarships. We also ran an optional Handicap Division, in which 223 bowlers participated and we will pay out \$2,300 to 23 bowlers. Six bowlers: **Christian**



Chan, Pamela Fallor, Andrew Chan, Sabrina Bennett, Lamaki Welch and Ashley Santos earned a FREE entry into the USBC Junior Gold Finals in Indianapolis, IN this July. Each of our six champions will receive a travel stipend up to \$400 for the Gold Finals along with their state scholarship (to be announced) and a custom embroidered jacket. All scholarship recipients will receive a scholarship packet and all funds will be held with USBC SMART. We will be distributing the scholarship packets at the California USBC Convention in Redding on June 11 and will mail the remaining packets directly to each bowler. 2016 BVL – The Bowlers to Veterans Link Hospitals and Presentations Report

The California Bowlers to Veterans (BVL) Committee conducted our distribution meeting in October 2015 by email, using an excel spreadsheet to review the requests from the California Veteran's facilities. The financial report was presented.

On behalf of the bowlers in California, the CUSBC BVL Committee has donated **\$117,586** to the following Veterans Centers in California for 2014-2015 season. From 1959 through 2014-2015 the California BVL Fund has donated **\$9,183,478.55** to our California Veterans. We want to thank all of you for your continued support of the California BVL.

We have completed all of the donations for this year and hope many of you will have a chance to visit a facility in your area. After meeting and talking with the Directors and Team Leaders, we know how proud they are of their facilities and they would all welcome your visit.

LEGISLATIVE COMMITTEE

First, I would like to thank my committee members that served this year on the legislative committee: Gary Forman, Linda Stewart, Pauline Armstrong, Ex-Officio's: President, Rosie Parker and Association Manager, Larry Peppers.

The committee met in mid-November 2015 and resolved to place the \$1.00 Dues increase on the ballot again this year. This measure is B-1 on the ballot.

That was all that was on the agenda for the committee at that time.

After the budget committee met and discussed the possibility of the dues increase being defeated, they went back to the committee to explore ways to decrease the board size to further cut back on association expenses.

The committee met again in January 2016 and brought forth the following by-law changes if the dues increase was defeated:

Proposal B-2 will decrease the current board from 18 members to 8.

Proposal B-3 amends the stagger system for director elections to accommodate only 8 directors.

Proposal B-4 removes the 2nd and 3rd Vice presidents.

Proposal B-5 reduces the number of board member for a quorum from the current 10 members to 6 members.

All 5 proposals were approved by the Board of Directors at the mid-year meeting.

Proposals B-2 thru B-5 will be withdrawn if B-1 passes.
