EACH BOWLER IS RESPONSIBLE FOR KEEPING A RECORD OF THE NAMES, DATES, SCORES AND PRIZE WINNINGS IN ALL TOURNAMENTS ENTERED IN THE PREVIOUS TWELVE (12) MONTHS.

PRIZE WINNINGS

USBC RULE 319D: PROVIDES THAT A BOWLER WHO HAS QUALIFIED FOR A CASH AND/OR MERCHANDISE PRIZE OF \$300 OR MORE IN ANY EVENT IN A TOURNAMENT WITHIN THE PREVIOUS 12 MONTHS MUST REPORT HIS/HER ACTUAL SCORE, POSITION AND AMOUNT WON TO THE TOURNAMENT DIRECTOR AT THE TIME OF BOWLING FOR POSSIBLOE RERATING OF AVERAGE.
