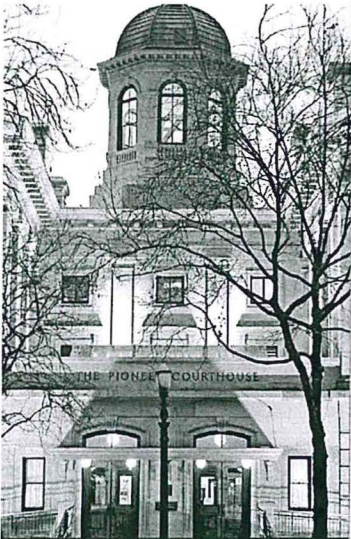

The minutes were done by Larry Peppers.</p> <p>8 Do you want to say anything on them? Okay.</p> <p>9 There were some corrections, and they were</p> <p>10 done by the court reporter that we had last year. So I</p> <p>11 am now entertaining a motion to accept the minutes.</p> <p>12 DON WAY: Don Way from San Diego USBC. I make</p> <p>13 a motion that we accept the minutes as written.</p> <p>14 PRESIDENT BRUEGMAN: Is there a second?</p> <p>15 ERNIE SANTOS: Second.</p> <p>16 PRESIDENT BRUEGMAN: Is there any discussion?</p> <p>17 Hearing none, I will call for the vote. I hope you have enjoyed this weekend, and we</p> <p>4 look forward to seeing you next year, and I have nothing</p> <p>5 else to add.</p> <p>6 Larry, do you have anything to add to your</p> <p>7 report? Larry Worrall.</p> <p>8 LARRY WORRALL: No.</p> <p>9 PRESIDENT BRUEGMAN: Thank you.</p> <p>10 David Waybright.</p> <p>11 DAVID WAYBRIGHT: No.</p> <p>12 PRESIDENT BRUEGMAN: Thank you.</p> <p>13 The directors, do any of the directors have</p> <p>14 anything to add to their reports in the packet?</p> <p>15 No?</p> <p>16 Okay. 14	<p>1 Thank you.</p> <p>2 Now here today are Shelby Sands, Tim Potal,</p> <p>3 Andrea Sisk, and Larry Campbell.</p> <p>4 We have our information in the packet but a</p> <p>5 couple things I wanted to highlight. In the packet you</p> <p>6 have the \$1,000 Youth State Scholarship application. We</p> <p>7 don't feel that we get enough of these back, so please</p> <p>8 make sure your bowlers get a copy of this form to fill</p> <p>9 out even if you don't think they qualify. Please make</p> <p>10 sure you submit it, because, you know, I just don't</p> <p>11 think we get enough for the entire state of California.</p> <p>12 We have a new scholarship award in the name of</p> <p>13 George and Ola Braun. Ola was a CWBA past president and</p> <p>14 1978 meritorious recipient, and George participated in</p> <p>15 150 tournaments. I don't know if you want to create an</p> <p>16 award in their honor. This is a 1,000 scholarship. The</p> <p>17 family will receive a winner with our help, but we want</p> <p>18 to pass that on and hopefully we get some applications</p> <p>19 for that.</p> <p>20 Lastly, we have this California Youth State</p> <p>21 Award application for 300, 299, 298, 11 in a row our 700</p> <p>22 for girls. Tom would like to give out most of those, so</p> <p>23 all youths are eligible as long as the scoring or league</p> <p>24 is certified.</p> <p>25 So if you have any questions, Tom is the guy</p>	16
15	<p>1 for that. So that's it.</p> <p>2 PRESIDENT BRUEGMAN: I could never get my</p> <p>3 voice that deep. But he speaks with authority.</p> <p>4 We will go into our championship tournaments.</p> <p>5 I will call Jennie Simpson for the open and women's</p> <p>6 report.</p> <p>7 JENNIE SIMPSON: Good morning, everybody.</p> <p>8 Just wanted to briefly say, but Larry already touched on</p> <p>9 it, we do have an increase to 416 of the entries this</p> <p>10 year. I wanted to say thank you to Time to Bowl for</p> <p>11 hosting us this year. Larry Campbell can't be here, but</p> <p>12 he was very influential in getting us there this year</p> <p>13 and has been a huge help.</p> <p>14 A big thank you to all the directors and our</p> <p>15 madam president for helping us out this year. Thank</p> <p>16 you, Kathy, Larry Peppers, Paul Kramer, and Mabel</p> <p>17 Sheasley, and Al Hoffman for being there as well.</p> <p>18 Thank you for helping us out this year. I</p> <p>19 would not have been able to do it without your help. So</p> <p>20 thank you for making this a big success, and thank you</p> <p>21 to all the bowlers that have shown up to make this a big</p> <p>22 success. Couldn't do this without you, so thank you for</p> <p>23 continuing to bowl in the state tournament.</p> <p>24 PRESIDENT BRUEGMAN: The Youth Championship.</p> <p>25 Lynn.</p>	17
14	<p>1 LYNN MATSUBARA: So there is a report on the</p> <p>2 website, but I will highlight we had 120 teams last</p> <p>3 year. This was at Keystone Lanes, and we awarded over</p> <p>4 30,000 – yes, over \$30,000 for only 120 teams. I mean</p> <p>5 that is huge. So that dollar increase that we got a</p> <p>6 couple years ago, I mean that is so amazing. So</p> <p>7 hopefully more of the kids preferably in the north,</p> <p>8 because we do get a lot of south representation, so</p> <p>9 hopefully they will see that benefit which I did explain</p> <p>10 that at Pepsi.</p> <p>11 I did see a couple of new entrees coming in</p> <p>12 this year in Orville. So yeah, that is almost – well,</p> <p>13 lineage comes out of that entry fee, but everything else</p> <p>14 is straight to scholarship. It is a huge allocation, so</p> <p>15 please push that in your center for state tournaments.</p> <p>16 We are going to be there three weekends in Orville this</p> <p>17 year. That's a lot of travel for me.</p> <p>18 Anyways, yeah. We would like to see that.</p> <p>19 And since we do give out free entries in the state</p> <p>20 through Pepsi tournament, we get a lot of new bowlers.</p> <p>21 And there is a lot of kids. They don't have enough</p> <p>22 people to make a full team, you know, four, so they tell</p> <p>23 me, and I put them together, and sometimes we have three</p> <p>24 or four Pepsi teams, because I am wrangling all these</p> <p>25 straggling winners together. So it kind of works out</p>	16
15	<p>1 they are making friends, and it is a win, win.</p> <p>2 But Jewel City, they are always on top. They</p> <p>3 are in Southern California in Glendale. They brought 12</p> <p>4 teams last year to Keystone, and they are still bringing</p> <p>5 19 this year up to Orville. So they travel as a huge</p> <p>6 group. I don't know if they take a bus, but they</p> <p>7 actually were doing fundraisers for the hotels, and they</p> <p>8 had a really great samaritan in their center who</p> <p>9 basically donated paying for their whole entire hotel</p> <p>10 fee. It was like \$9,000. The guy donated all the</p> <p>11 money, so it is pretty amazing what they do for these</p> <p>12 kids, and they have a lot of special needs kids in their</p> <p>13 group, too, which is really great.</p> <p>14 So that's a huge experience for them when they</p> <p>15 come up and bowl the tournament. So it is nice to see</p> <p>16 them and their families together.</p> <p>17 So there is a report last year for Keystone.</p> <p>18 We did have a 300. We had two 800's. Those were first</p> <p>19 time honor scores for those kids, and hopefully, I know</p> <p>20 one turned adult. He is going to college now, but the</p> <p>21 other two I believe are still in junior. So they should</p> <p>22 able to come out this year and try again. That's it for</p> <p>23 youth.</p> <p>24 Oh, yeah. So new for this year, Kathy and</p> <p>25 Larry went to a seminar, meeting at USBC, and an idea</p>	17



18	<p>1 that came out from another state –</p> <p>2 Do you remember what state that was?</p> <p>3 – another state for their youth state</p> <p>4 tournament. They grabbed a lane position and a lane</p> <p>5 number, and they award that person a \$100 scholarship.</p> <p>6 We will try that this year.</p> <p>7 We have some unassigned scholarship phones. I</p> <p>8 have an app on my phone that will randomly draw numbers,</p> <p>9 so we will do that. We will promote it, and I will get</p> <p>10 it up on the website so the coaches will know. So it is</p> <p>11 not based on your score, it is just your lucky lane and</p> <p>12 number. There is already gambling in Orville, so I am</p> <p>13 sure at least the kids can get something.</p> <p>14 I will move on to Pepsi. And Pepsi we just</p> <p>15 finished this year's event. This is the longest</p> <p>16 tournament, runs from November to May, and I just got</p> <p>17 the money finalized actually earlier this week. So we</p> <p>18 are paying out \$50,000 in scholarships, which is</p> <p>19 awesome, and we have actually eight winners this year</p> <p>20 instead of six because USBC added another division, so</p> <p>21 we have under eight, under 10, under 12, under 15, under</p> <p>22 17 and under 20 divisions. But for the state final we</p> <p>23 only take the under 12 and higher divisions. So we have</p> <p>24 eight winners now instead of six. Those eight people</p> <p>25 technically with birth go into the Junior Gold</p>	20
19	<p>1 Championships in July, but a lot of them also have</p> <p>2 entries in gold, so we go down the line to the next</p> <p>3 person.</p> <p>4 We have some new people. They were north</p> <p>5 champions, but they are going to gold. So we filled</p> <p>6 eight spots. Nobody turns down those spots, really, and</p> <p>7 it is in Detroit Michigan this year.</p> <p>8 Last year one of our bowlers, Kaitlen Abagon</p> <p>9 (phonetic) from San Diego won her division from Pepsi.</p> <p>10 She won junior goal up there in Cleveland – Texas, in</p> <p>11 Texas last year. So she is on her fame tour now. She</p> <p>12 was actually on Ryan and Kelly Live. We showed that</p> <p>13 video yesterday at David's meeting. So she is having a</p> <p>14 ball. And she actually won again this year for her</p> <p>15 division which is really great. But a lot of the girls</p> <p>16 – We always want more girls in the divisions, but the</p> <p>17 girls that we had are all repeat winners. Jennifer</p> <p>18 Loreda, she won her division again for the third time,</p> <p>19 and she won Junior Gold the previous year. So we have a</p> <p>20 lot of really great bowlers, and it shows.</p> <p>21 When we go out of state, we purposely make –</p> <p>22 we do Andre shop for our tournament which is really</p> <p>23 tough, but it makes a difference, because when they go</p> <p>24 to bowl gold or anything else with a tough shot they are</p> <p>25 not shocked and just like impossible.</p>	21



22	<p>1 And yeah, I have major respect for all you guys that run                  2 tournaments now. I understand what you guys go through.                  3 I did get saved by a youth director named                  4 Annette Anderson.                  5 Yeah. Stand up.                  6 She had a computer ready for us, and helped us                  7 get the Mystery Doubts partnered up. So we had 16                  8 entries. And we paid out the first through third, and                  9 we actually had a kid shoot his first 300 there, Daniel                  10 Hong. He is 15 years old.                  11 So our first place winners were of course                  12 Daniel Hong and Mark L, because I don't want to butcher                  13 his last name and Ronnie Castillo and Stephanie Hong,                  14 and then third place was Allison Acevedo and Donald                  15 Wade.                  16 It was a really fun tournament, and we are                  17 going to have it again next year, and hopefully it will                  18 be each and every year from here on out.                  19 PRESIDENT BRUEGMAN: Thank you, Lynn and                  20 David. Now you know what it is like, huh?                  21 DON WAY: Madam, may I say something?                  22 PRESIDENT BRUEGMAN: Yes you may.                  23 DON WAY: I participated in the tournament.                  24 It was great. So if you know of anyone, please let us know.                  2 The amount of money that was donated by                  3 associations last year for this '18/'19 season was                  4 \$100,090,12.                  5 Last night we, during the luncheon or the                  6 dinner, Awards Dinner, we had Paul Kramer go around                  7 spelling raffle tickets for a BVL bowling ball. He                  8 collected \$565. So our total is 100,155.12.                  9 Paul, thank you very much.                  10 We had some awards here last evening that were                  11 not presented. I would like to have someone from Orange                  12 County come up. We have a plague here for them. They                  13 donated \$8,601.                  14 Thank you, Gary.                  15 The next one is for San Diego USBC. Their                  16 donation was \$12,849.
