Welcome to the 2022 California Pepsi USBC Youth Championships. Enclosed is the tournament information needed for this season. ***NEW* this year is that there will NOT be any league level qualifying. Bowlers can now enter directly into the District Finals through California USBC certified youth leagues. Interested participants will need to be submitted on the official Pepsi entry forms through the league. BLS software can still be used – just select the bowlers in each division that want to participate.**

With the lowering of the youth age eligibility restriction to 18, the tournament divisions are slightly adjusted. The ten age divisions are: **U8, U10, U12, U15 & U18** (Boys & Girls).

Handicap and scratch scholarships will be awarded to the U8 & U10 divisions at the District Finals in March – they will NOT move on to the State Finals in May. U12, U15 & U18 divisions are competing for Handicap scholarships and qualifying (scratch) to the **PEPSI STATE FINALS** (May). We have also increased the travel stipend to \$500 for the six division champions that attend the 2022 Junior Gold Championships in Michigan.

IMPORTANT INFORMATION:

- 1) **Averages as of FEBRUARY 5 will be used.** Please include league sheets received on February 12 as they will include the scores from February 5. Also include any previous FALL LEAGUE ENDING sheets (prior to February) as well.
- 2) Champions in the U8 and U10 divisions at the District Finals will earn a single entry (\$80 value) into all four events of the California Youth State Championships to be held **July 2022** at **Forest Lanes** in Lake Forest.
- 3) First Place scratch finishers in the U12, U15 & U18 Divisions at the District Finals will earn \$50 scholarships and qualify into the Diddy Watts Youth State Singles Challenge Semi-Finals (Aug 6-7, 2022; Location TBA).
- 4) **IT IS THE STATE FINALIST'S RESPONSIBILITY TO CHECK ONLINE TO SEE IF THEY QUALIFIED TO THE STATE FINALS AND TO REGISTER ONLINE APRIL 1-10. State Finals Registration (U12, U15 & U18 Divisions) is ONLINE ONLY at CALUSBC.com.**
- 5) **NEW!** The six division champions in the U12, U15 & U18 Divisions will receive a **Strike12Creations.com** jersey (set design) to wear at Junior Gold!

For the 22nd year in a row, **BowlersParadise.com** will be sponsoring this event along with **EliteBowling.com**. Also, each pro shop in the eight hosting Pepsi District Finals will be donating a bowling ball for our fundraising raffle at each site to help us raise even more scholarship dollars. IMPORTANT: Turn in paperwork early to reserve your squad times! Late entries will NOT be accepted, so please be sure to turn in paperwork no later than **FEBRUARY 18**. Enclosed is your District Director's contact and tournament information (dates/fees). Contact us immediately if you have received the wrong district information and we will get you the correct packet ASAP. **PLEASE have all coaches and bowlers READ the TOURNAMENT INFORMATION & RULES carefully.** If you have questions, contact your District Director immediately. Thank you for your support and participation in one of the largest scholarship events in California. We worked extremely hard with your help in raising funds so that we

could award \$50,000 in scholarships for 2019! With the rising cost of education, this tournament strongly benefits many young bowlers on their way to a promising future. We have included a poster to display in promoting this tournament. *GOOD LUCK WITH YOUR PROGRAM THIS YEAR!*

- Final level of competition for the U8 & U10 Divisions earning scratch and handicap scholarships (1:10 ratio per division)
- U12, U15 & U18 Divisions compete for scholarships and advancement (scratch) to the State Finals (1:5 ratio per division). **STATE FINALIST'S MUST CHECK ONLINE TO SEE IF THEY QUALIFIED AND MUST REGISTER ONLINE (APRIL 1-10) IN ORDER TO BOWL.** First place scratch finishers will also qualify into the Diddy Watts State Singles Challenge Semi-Finals in Aug.
- **Champions from the U8 and U10 divisions will earn a single entry (\$80 value) into all four events of the 2022 California Youth State Championships to be held at Forest Lanes, Lake Forest (July).** See District Rules for eligibility.

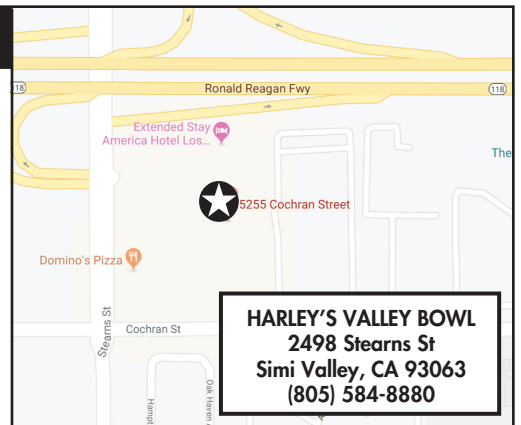

16. **California is allocated 6 berths into the Junior Gold Championships. The first-place winners of the U12, U15 and U18 divisions for both Girls and Boys will advance to the 2022 Junior Gold Championships on July 11-23, 2022 in Michigan.** Berth winners must be USBC Junior Gold members to advance to the Junior Gold Championships. Bowlers without a current Junior Gold membership must purchase a Junior Gold membership prior to June 8. IBC Youth will waive the \$200 (U18), \$150 (U15), and \$100 (U12) entry fee for these athletes. These athletes will compete for additional scholarships available to all athletes at the Junior Gold Championships, as well as other prizes and awards. All U.S. citizens are vying for a spot on USBC Junior Team USA 2023 to represent the United States in national and international competition. If the U12, U15 or U18 Division Champion is unwilling to become a Junior Gold member, they will not advance to the Junior Gold Championships. However, the athlete will still retain the state scholarship, but the berth to the Junior Gold Championships will be awarded to the next eligible athlete. Eligible advancers must agree to bowl in the Junior Gold Championships, or, failing to do so, agree to waive all rights. Replacements will be selected based on the order of finish in their division at the state level. Replacements will incur all costs associated with changing the airline ticket, if applicable. If the eligible advancer decides not to attend the Junior Gold Championships, any stipends offered will be forfeited. However, any scholarships earned at the state level will be retained. **The California USBC Association will provide the U12, U15 & U18 Champions (6 total) a travel stipend valued up to \$500.** Arrangements will be made by each athlete within stated guidelines and parameters from the California USBC Association. **Berth winners are not confirmed until they receive confirmation from USBC.**
17. **Practice is prohibited** in the hosting center during the weekend of competition (Saturday night).
18. **Only a dry towel or cleaning with isopropyl alcohol may be used during USBC competition.**
19. Claims for errors in scoring or general playing rules must be made to the Tournament Director no later than the start of the next block or 30 minutes after the completion of competition. Questionable errors shall be decided upon by the Tournament Director. All other protests must be confirmed in writing to the tournament director within 72 hours of the infraction. Under this rule, each protest must be specific in itself.
20. All matters not covered by these rules and regulations shall be determined by the California Pepsi USBC Youth Championships Tournament Committee. The National Pepsi USBC Youth Championships Tournament Committee reserves the right to accept or reject any participant.

2022 CALIFORNIA PEPSI CHAMPIONSHIPS TIDBITS

- x To date, the Pepsi Youth Championships nationwide has awarded more than \$6 million in scholarships – it is estimated that at least \$500,000 in scholarships will be awarded nationwide this season alone. ***By conducting the league level competition you are giving your bowlers an opportunity to help finance their college education. California awarded \$50,000 in scholarships in 2019 and has awarded over \$1,000,000 since 1998.***
- x **NEW!** Bowlers can now enter directly into the District Finals as long as they are entered in a California youth league for the 2021-22 season. **Paperwork must be submitted through California USBC certified youth leagues.**
- x **The CALIFORNIA PEPSI USBC LEAGUE HANDBOOK is available online only at CALUSBC.com.** This handbook contains information and worksheets needed to conduct the league level competition. The District and State Finals rules are also enclosed in this packet. Please make sure that all Coaches and bowlers read this information.
- x All USBC certified youth bowlers should have a chance to participate in one of the largest scholarship tournaments in California! All levels of qualifying use scratch scores.
- x Contact your local District Director if you need any help with completing the Pepsi paperwork. (The enclosed **PINK sheet** contains tournament info, locations and fees for your district). Check your district number on the back of the cover letter and make sure you have the correct District Finals tournament information for your center.
- x Turn in **LEAGUE SHEETS** dated as of 2/5/22 and **FALL LEAGUE ENDING league sheets** (if applicable) to your District Director along with the summary sheet and fees. We also need copies of the USBC membership listings so that we can verify that every qualifier is currently certified before they bowl in the District Finals. Memberships are not sold on-site.
- x Fees and paperwork for the District Finals are due no later than **FEBRUARY 18**. Turn in paperwork early to reserve your preferred squad times.
- x California will run a separate **HANDICAP division** at the District Finals – EVERYONE WILL BE ENTERED. This division will be optional at the State Finals. **Handicap: 100% of 210.**
- x To help award more scholarship dollars, there is going to be a **\$10 ON-SITE FEE** for those competing in the State Finals in May.
- x Champions, scholarship placement and Junior Gold berths are determined by total scratch pinfall per division at the State Finals.
