Bowlers in the U12, U15 & U18 scratch events will qualify from District to State based on a ratio of 1:5 or major fraction thereof, including last place ties per division. All qualifiers are marked in the scratch results and are posted online at [CALUSBC.com](http://CALUSBC.com). It will be the bowler's responsibility to check for their name online to see if they qualified. **State Finalists must REGISTER their squad time online in order to bowl in the State Finals at Harley's Valley Bowl, Simi Valley on April 30-May 1. THE RSVP WINDOW IS APRIL 1-10.** At the State Finals, each division will earn scholarships and one of six berths into the Junior Gold Championships to be held in Michigan if they have not already previously qualified. The California USBC will also provide each division champion with a travel stipend to Michigan valued up to \$500.

**The OFFICIAL results with scholarship breakdowns will be available by June 1. All funds raised from this district will remain in this district's scholarship fund and will be pro-rated by division.** We encourage your youth bowlers to visit us often at [CALUSBC.com](http://CALUSBC.com) to receive information on scholarship awards and other tournaments available such as our Youth State Championships held this summer in Lake Forest (July) and the Diddy Watts Youth State Singles Challenge (formerly the State Scratch Youth tournament) held June 25-26 (local qualifiers) and August 6-7 (Bowlero Visalia). We also offer a \$2,500 Star of Tomorrow Award and a \$1,000 youth scholarship award for High School Juniors/Seniors. **STATE FINALS QUALIFIERS:** State Finalists (U12, U15 & U18 divisions) will qualify (scratch) from District to State based on a ratio of 1:5 or major fraction thereof, including last place ties per division. **IT IS THE STATE FINALIST'S RESPONSIBILITY TO CHECK ONLINE AT CALUSBC.COM TO SEE IF THEY QUALIFIED TO THE STATE FINALS. QUALIFIERS MUST REGISTER THEIR SQUAD TIME ONLINE (APRIL 1-10) IN ORDER TO BOWL.**

Space is limited and filled on a first come, first serve basis.

**FORMAT: \$10 ON-SITE FEE.** Qualifiers must select one squad, which consists of 6 games moving pairs after each game.
