TOURNAMENT OVERVIEW

California



The Pepsi USBC Youth Championships is a multi-level nationwide qualifying championship event for USBC certified youth bowlers. This tournament is a benefit of USBC youth membership — every youth bowler should be given their chance to enter. California awarded over \$60,000 last year and has awarded over \$1,000,000 since 1998.

Please remember: An athlete is not required to belong to the Junior Gold Program to bowl in the U12, U15 or U18 divisions. If an athlete does win the U12, U15 or U18 Division and they are not a Junior Gold Program member, they must purchase membership prior to the 2025 Junior Gold Championships to compete. If they are unwilling to purchase membership, the athlete keeps any awards given from the state, but will not be allowed to advance to the Junior Gold Championships and an alternate will be chosen.

This handbook contains information for the California Pepsi Youth Championships. The 2024-25 League Level Rules must be followed and supplied to each athlete. USBC and your California Pepsi Youth Championships Tournament Committee thank you for your support, dedication and cooperation. CALIFORNIA PEPSI LEAGUE ENTRY

DEADLINE: FEBRUARY 18

Competition is open to all current California USBC Youth members that are bowling in 2024-25 California USBC certified youth leagues and not under suspension. League substitutes are allowed to enter if it is their only league. Entries must be submitted by Youth Program Directors, when possible. **OFFICIAL PEPSI ENTRY FORMS are provided in this handbook and available online at CALUSBC.com. One entry form per division. Use the PEPSI SUMMARY FORM when submitting entry forms and payment.** Sport and Challenge leagues must be notated. Sole verifiable “sport/challenge” averages will be adjusted per the USBC Sport/Challenge Average Chart.

Entry forms must be accompanied by the PEPSI SUMMARY SHEET and:

- ✓ Address, phone, email and birth date information for all participants
- ✓ League sheets dated as of **FEBRUARY 15** plus any fall league-ending sheets
- ✓ 2024-25 USBC youth league membership list showing USBC ID#s and current dues paid
- ✓ Opt Up Waivers for U8/U10 divisions that want to compete in the U12 division to try and qualify for the State Finals.
- ✓ Entry fee payment – one center check or money order made payable to **CUSBC**.

Pepsi competition is held in ten divisions based on the bowler’s date of birth:

- ⊛ U8 Boys/Girls whose birthdate is 8/1/16 or later
- ⊛ U10 Boys/Girls whose birthdate is 8/1/14 thru 7/31/16
- ⊛ U12 Boys/Girls whose birthdate is 8/1/12 thru 7/31/14
- ⊛ U15 Boys/Girls whose birthdate is 8/1/09 thru 7/31/12
- ⊛ U18 Boys/Girls whose birthdate is 8/1/06 thru 7/31/09

**Bowlers in the U8/U10 divisions can “OPT UP” to enter into the U12 division to try and qualify to the State Finals. The waiver must be submitted with the entry fee. Waivers are included in this handbook.*

CALIFORNIA PEPSI DISTRICT FINALS

California is divided into six Districts based on location and local USBC associations. Each District runs their own event. District Finals fees are \$35 for U8 & U10 Divisions and \$65 for U12 & above divisions. Pepsi entry forms, supporting documents and fees must be postmarked by **FEBRUARY 18** and must be submitted to their respective District Director who will process and schedule your bowlers. **League sheets dated as of February 15 also need to be provided for verifying averages.** Any leagues that end prior to February must also submit their league ending sheets. See **tournament packet** or visit **CALUSBC.com** for District site locations, format and District Director contact information.

DISTRICT FINALS FORMAT: Three games total. One-time entry. Scratch and handicap scholarships are awarded to the U8 and U10 divisions (1:8 ratio) – they do not advance to the State Finals. U12, U15 & U18 divisions will earn handicap scholarships and are vying to qualify scratch to the **PEPSI STATE FINALS** (May).

- **U8 & U10 Division Champions (Boy/Girl) will earn a FREE entry into the 2025 CA Youth State Championships at 4th Street Bowl in San Jose (June 21-22, 2025; 24 entries).**
- **First place scratch finishers in the U12, U15 & U18 Divisions will earn \$50 scholarships (36 bowlers)**
- **State Finalist's MUST check online at CALUSBC.com TO SEE IF THEY QUALIFIED and register APRIL 1-8 in order to compete**

Bowlers will advance from District to State based on a ratio of at least **1:4**, or major fraction thereof, including last place ties per division using scratch scores. **ALL BOWLERS MUST CHECK ONLINE AT CALUSBC.COM TO SEE IF THEY ARE STATE QUALIFIERS and MUST REGISTER THEIR SQUAD TIME (APRIL 1-8) IN ORDER TO PARTICIPATE.** Those who fail to register their squad time without prior notification to the Tournament Director will forfeit their spot.

STATE FINALS FORMAT: Five games total moving pairs after each game. One-time entry. All divisions are competing for scratch and handicap scholarships (1:8 ratio) and six **FREE BERTHS** (one per division; scratch scores) into the 2025 USBC Junior Gold Championships July 11-19, 2025 in Green Bay, WI.

- **NO ENTRY FEE**
- The six Champions will receive the following:
 - **FREE BERTH** into the 2025 Junior Gold Championships to be held July 11-19, 2025 in Green Bay, WI (if they have not previously qualified).
 - **TRAVEL STIPEND** up to \$500 for Junior Gold travel to Green Bay, WI and a **STRIKE12CREATIONS.COM** jersey (CA design) to wear at Junior Gold representing California! (Stipend and jersey are voided if the bowler does not attend Junior Gold). California USBC will set the parameters for the travel stipend and the jersey offer.

JUNE 21-22, 2025

California Pepsi Championships District Finals U8 and U10 Division scratch champions (24 total) will earn a single entry into the California Youth State Championships. In order to redeem this award, the winner must be entered with a full team and in singles event. This berth is applicable only to the four Champions (U8 & U10 Boys and Girls) in each District and will be voided if they cannot attend or do not enter with a full team entry. The entry must be paid in full. After the bowler's scores are confirmed, the reimbursement will be issued. California USBC will set the parameters for the reimbursement.

USBC JUNIOR GOLD CHAMPIONSHIPS

GREEN BAY, WI

July 11-19, 2025

The U12, U15 & U18 Division Champions will receive a **FREE BERTH** (one per division) from USBC into the 2025 USBC Junior Gold Championships (if they have not already qualified). Bowlers without current USBC Junior Gold membership must purchase membership prior to June 8. Gold applications are included in this handbook. Gold competitors will compete for additional scholarships as well as vying for a spot on USBC Junior Team USA to represent the US in national and international competition (US Citizens). Berth winners are not confirmed until they receive confirmation from USBC.

Star of Tomorrow Scholarship Award \$2,500 Scholarship

High school seniors are eligible. Star qualities include distinguished certified bowling performances on state, local, national, international, Team USA, or collegiate levels as well as academic achievement and leadership.

California Youth State Scholarship \$1,000 Scholarship

Applicants must be youth members of the California USBC Association. Points are graded for both academic and bowling participation. One-time award.

Braheme Family Memorial Youth Scholarship \$1,000 Scholarship

This scholarship is in the name of George & Ola Braheme. Ola was the California Women's Bowling Association (CWBA) Past President and 1978 CWBA Meritorious Service award recipient. George participated in 50 consecutive California State Tournaments. Both are inducted in the Salinas USBC Hall of Fame. Applicants must be current youth members of the California USBC Association. Points are graded for both academic and bowling participation.

LEAGUE ENTRY

- Competition is open to all 2024-25 USBC Youth members entered in a California USBC certified youth league
- Entries must be submitted by Youth Program Directors through CA USBC certified youth leagues
- Ten age divisions: (Boys & Girls) U8, U10, U12, U15 & U18
- U8/U10 divisions may "OPT UP" into the U12 division by submitting a waiver with entry fees
- Paperwork and fees are due by **FEBRUARY 18**
- Participation in more than one District will result in automatic disqualification

DISTRICT FINALS (10 DIVISIONS)

- Entry forms, supporting documents and fees are due to District Directors **FEBRUARY 18** (See pink sheet in packet)
- District Directors will process paperwork and schedule centers based on entries received
- Format: Three games total; One-time entry
- Six District Finals locations in March (two different weekends)

U8 & U10 Divisions

- \$35 Entry Fee
- Scratch and Handicap scholarships awarded (1:8 Ratio per division)
- First place scratch finishers in the U8 & U10 Divisions (24 bowlers) will earn a FREE entry into the California Youth State Championships at 4th Street Bowl, San Jose (June 21-22, 2025; See District rules)

U12, U15 & U18 Divisions

- \$65 Entry Fee
- Handicap scholarships awarded (1:8 Ratio per div)
- \$50 Scholarship for First Place Scratch Finishers per division
- Qualify to State using scratch scores (1:4 Ratio)
- State finalists must register their squad time (APRIL 1-8)

STATE FINALS

(U12, U15 & U18 Divisions)

- NO ENTRY FEE
- ALL BOWLERS MUST REGISTER THEIR SQUAD TIME (APRIL 1-8) IN ORDER TO PARTICIPATE
- Five games total moving pairs after each game
- Scratch & handicap scholarships awarded in each division (1:8 ratio)
- Six FREE berths awarded into the Junior Gold Championships held July 2025 in Green Bay, Wisconsin (if they have not already qualified)
- Division champions will earn a travel stipend up to \$500 for travel to Wisconsin for Junior Gold.
- Division champions will earn a FREE Strike12Creations.com jersey to wear at Junior Gold to represent California. (Jersey offer voided if the bowler does not attend Junior Gold)

Highest total scratch pinfall per division determines PEPSI CHAMPIONS, SCHOLARSHIP PLACEMENT and JUNIOR GOLD berths

USBC Junior Gold Championships July 11-19, 2025 – Green Bay, WI

Bowlers without a current Junior Gold membership must purchase a membership prior to June 8. Athletes will compete for additional scholarships available to all athletes at the Junior Gold Championships. All U.S. citizens are vying for a spot on USBC Junior Team USA to represent the US in national and international competition. If the berth winner is unable to attend, the Junior Gold Championships berth will be awarded to the next eligible athlete.

FEBRUARY 18

ENTRY DEADLINE for all Pepsi entry forms, supporting documents and fees to District Directors. Paperwork must be submitted on official **PEPSI LEAGUE ENTRY FORMS** or **BLS** for all divisions. Competition is open to all 2024-25 USBC Youth members entered in California USBC certified youth leagues. League substitutes are allowed to participate if it is their only California USBC certified youth league. Entries must be submitted through the youth league by Youth Program Directors.

One-time entry. Three games total. U8/U10 divisions will earn scholarships and FREE entries into the 2024 CA Youth State Championships in June (4th Street Bowl, San Jose). The U12/U15/U18 divisions will also earn scholarships and are vying to qualify into the Pepsi State Finals.

ALL QUALIFIERS MUST REGISTER THEIR SQUAD TIME (APRIL 1-8) IN ORDER TO PARTICIPATE.

Qualifiers names are posted at CALUSBC.com. Each registration will be verified and confirmation emails will be sent no later than April 27. Those who fail to register their squad time without prior notification to the Tournament Director will forfeit their spot.

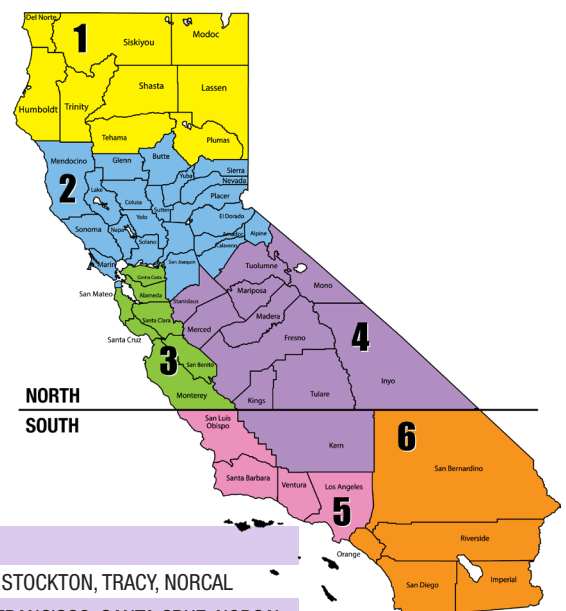

2024-25 CALIFORNIA LEAGUE RULES

ATHLETES MUST READ THESE RULES AND CONFIRM THEIR DIVISION PRIOR TO COMPETITION

1. The Pepsi Youth Championships is certified by the United States Bowling Congress and governed by USBC rules.
2. Competition is open to all 2024-2025 USBC Youth members. To compete, a bowler must be a member of a certified USBC youth league and not be under suspension at the time of qualifying. League substitutes are allowed to participate if it is their only USBC Youth league. USBC Collegiate members are eligible if they are 2024-25 USBC youth members, bowl in a USBC Youth league and have not violated USBC Rule 400.
3. Bowling centers having 2024-2025 USBC certified youth leagues are eligible sites. **Entries must be submitted through California USBC certified youth leagues.**
4. Competition will be conducted in 10 divisions based on the participant's date of birth as listed below. Participation in the wrong age division will lead to automatic disqualification. Bowlers must stay in the given division in that particular league throughout the entire window.

⇒U8 Boys	Bowlers whose birthdate is 8/1/2016 or later	⇒U8 Girls
⇒U10 Boys	Bowlers whose birthdate is 8/1/2014 thru 7/31/16	⇒U10 Girls
⇒U12 Boys	Bowlers whose birthdate is 8/1/2012 thru 7/31/14	⇒U12 Girls
⇒U15 Boys	Bowlers whose birthdate is 8/1/2009 thru 7/31/12	⇒U15 Girls
⇒U18 Boys	Bowlers whose birthdate is 8/1/2006 thru 7/31/09	⇒U18 Girls

***One way to think about this is....** If a bowler turns 9, 11, 13 or 16 during the bowling season he/she would be in the next highest age division.

***There is no requirement of Junior Gold membership to enter U12, U15 or U18 Division!**

5. Participants can attempt to qualify in any state where they hold a 2024-25 USBC Youth membership card. However, the bowler can only advance once using the following criteria:
 - a) In the event a bowler enters from more than one league in the same division, the member must pick which league they want to represent.
 - b) If a bowler qualifies in different leagues from multiple divisions, the bowler must select one division they will compete in before subsequent competition.
 - c) If the bowler enters in more than one state, the bowler must declare one state to continue competing in before the next competition level.
 - d) Participation in any level of competition past the league level in more than one state and/or more than one division will result in automatic disqualification.

Note: Advancers must remain in the division they entered during all subsequent competition.

2024-25 CALIFORNIA LEAGUE RULES

ATHLETES MUST READ THESE RULES AND
CONFIRM THEIR DIVISION PRIOR TO COMPETITION

STATE LEVEL

6. The top one (1) bowler in the U12, U15 and U18 divisions for boys and girls at the state competition with the highest scratch score (plus applicable bonus pins) will earn a berth to the Junior Gold Championships. Bowlers are not required to have a minimum average or be a Junior Gold Program member to enter the U12, U15 or U18 Divisions at the local level of qualifying for the Pepsi Youth Championships. However, to receive the berth, the bowler must be a USBC Youth Standard member and Junior Gold program member no later than June 8, 2025. If the winner is not eligible for the championships, they will still retain all awards from the state, but the next eligible bowler will receive the berth to the Junior Gold Championships.
7. Advancers to the Junior Gold Championships must agree to bowl in the Junior Gold Championships or, failing to do so, agree to waive all rights. Replacements will be selected based on the order of finish in their division at the state level.
8. **If a bowler has already earned a berth into the Junior Gold Championships and wins either the U12, U15 and U18 division in the Pepsi Youth Championships, they would receive any scholarship and/or stipend assigned to their finishing position. The spot into the Junior Gold Championships would go to the next eligible athlete in line by order of finishing position.**
9. Failure to abide by any rules and regulations will lead to disqualification from this event. The Pepsi Youth Championships National Tournament Committee reserves the right to accept or reject any participant.
10. The Pepsi Youth Championships National Tournament Committee will decide all matters not covered by these rules and regulations, or USBC rules and regulations. All decisions are final.
