For bowlers that have qualified from District Finals to the State Finals. Qualifiers names are posted at CALUSBC.com.

## REGISTER: APRIL 1-8, 2025 • STATE FINALS: MAY 3-4, 2025

**STATE FINALS QUALIFIERS:** Bowlers in the U12, U15 & U18 divisions will qualify (scratch) from the District Finals (March) to the State Finals based on a ratio of **1:4** or major fraction thereof, including last place ties per division. **QUALIFIERS MUST REGISTER THEIR SQUAD TIME ONLINE (APRIL 1-8) IN ORDER TO BOWL.** Those who fail to register their squad time without prior notification to the Tournament Director will forfeit their spot. Hotel information is posted at CALUSBC.com.

**FORMAT:** NO ENTRY FEE. One-time entry. Five games singles moving pairs after each game. Each division will earn scratch and handicap scholarships and one of six berths into the 2025 USBC Junior Gold Championships in Wisconsin (if they have not already previously qualified). Champions, scholarships and Junior Gold berths will be determined by total scratch pinfall per division. The six division champions will receive scholarships plus a travel stipend up to \$500 for Junior Gold travel to Wisconsin and a **Strike12Creations.com** jersey (set CA design) to represent California. (The stipend and jersey will be voided if the champion does not attend Junior Gold.)

#### CALIFORNIA USBC ASSOCIATION - CAL STATE YOUTH QUEENS & MASTERS RULES

- 1. Open to all current California USBC youth members that are members of a current California youth league.
- 2. **DATES:** May 3-4, 2025. Entry closing date: May 4, 2025 unless squads are filled sooner.
- 3. The tournament will be held at **COUNTRY CLUB LANES**, 2600 Watt Ave, Sacramento CA 95821, 916-483-5105.
- 4. **FORMAT:** Five game singles moving pairs after each game. **Four divisions:** QUEENS (girls scratch), MASTERS (boys scratch), PRINCE (boys handicap) and PRINCESS (girls handicap). Prince and Princess is for averages 159 and below. Queens and Masters is open to any average. Total scratch pinfall will determine the standings for each division. One-time entry only.
- 5. **PRINCE & PRINCESS ENTERING AVERAGES:** USBC Rule 319c will apply. All participants must have an established CA USBC average.
  - A) Highest USBC certified average as of APRIL 1, 2025 (min. 15 games; PROVIDE LEAGUE SHEET), If none;
  - B) Highest USBC 2023-24 average (min. 15 games), If none;
  - C) Highest USBC 2023-24 composite average (min. 15 games), If none;
  - D) Scratch must bowl Queens or Master division

**SUBMIT BOWL.COM AVERAGE PROFILES AND LEAGUE SHEETS (if applicable) WITH EACH ENTRY.** Bowlers are responsible for verifying their own averages. If a "sport/challenge" league average is the bowler's only verifiable average, it should be marked with "SP/CH" in the average box and will be adjusted per the USBC Sport Chart to determine the correct entering average. USBC Rule 319a-2, 319d, 319e and 322b are waived.

- 6. HANDICAP: 100% of 160.
- 7. **ENTRY FEE:** \$75 per person (Lineage \$18.75 + Scholarship/Awards/Expenses \$56.25). **Zelle:** 562-449-4527; Paypal: info@calusbc. com, Venmo: @calusbcbowling2 or make checks payable to CUSBC. **Write "Youth QM and bowler's name" in memo/note.** Any returned payments must be paid in cash or money order on-site plus a \$35 penalty fee. No refunds after entries have been processed unless approved by the Tournament Director. **DO NOT MAIL ENTRIES AFTER APRIL 26.**
- 8. ONLY A DRY TOWEL FOR CLEANING MAY BE USED DURING COMPETITION. ELIMINATION OF BALANCE HOLES: Bowlers may have up to five holes for gripping purposes and all must be used on every delivery. If only fingers are used, the thumb hole must be plugged and an "X" marked for the palm position. Any bowling ball that does not meet USBC specifications will subject the bowler to disqualification of all tournament scores. We reserve the option to do random spot checks and we may be reported to check equipment by another bowler. Visit BOWL.com to download the Non-conforming Bowling Ball List. See Rule 8 Acknowledgement box on the front entry. VISIT CALUSBC.COM FOR RULE DETAILS.
- 9. Tardy bowlers shall start in the frame currently being bowled. Missed frames shall be credited with a zero. Bowlers not present to bowl when it's their turn will receive a zero for that frame.
- 10. Only bowlers and Tournament Officials are permitted in the settee area.
- 11. Disputes and complaints must be filed by participants only. Decisions by Tournament Management will be final.
- 12. **DISQUALIFICATIONS:** Non-alcoholic beer may NOT be consumed while participating in the tournament. No tobacco or smoking products permitted by participants. Conduct derogatory to the best interest of youth bowling in conjunction with USBC will result in immediate disqualification (Refer to rule 17D). Adults consuming alcohol must remain in the lounge or in back concourse area.
- 13. Oil patterns will be determined by Tournament Management.
- 14. All bowlers must check-in wearing proper attire. DRESS CODE: Bowling jerseys with or without name or plain polo shirts only with sleeves. Slacks, skirts or skorts only. No jeans or hats. No headphones or cell phones allowed in the bowler's area. The tournament chairman shall determine the validity of any complaints.
- 15. NO OUTSIDE FOOD ALLOWED INSIDE THE CENTER. Please be respectful of the hosting center's rules and guidelines.
- 16. Scholarships will be awarded based on the number of paid entries with a ratio of at least 1:8 per division, or major fraction thereof. Awards and Scholarship fees shall be returned 100%. All ties will be split equally. Scholarships will be held with USBC SMART Account #8512, (800) 514-2695 x8292.
- 16. Each Champion will receive a **Strike12Creations.com** jersey. Specifics to follow for each champion.
